Sealed Bids addressed to the Maine Department of Transportation, Augusta, Maine 04333 and endorsed on the wrapper **Maintenance Surface Treatment Paving** in the town/city of **North Yarmouth, Pownal, Durham, Gray, Falmouth, Cumberland, Mechanic Falls, Oxford, Standish** will be received from contractors at the Reception Desk, Maine DOT Building, Child Street, Augusta, Maine, until 11:00 o'clock A.M. (prevailing time) on **April 14, 2010** and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must have completed, or successfully complete, a Highway Construction or Paving Prequalification or project specific prequalification to be considered for the award of this contract. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening.** Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.

Location: In Cumberland, Androscoggin, and Oxford Counties, project is located

Map ID 1 is in N Yarmouth, Pownal, Durham - Rte 9, From the jct of Parsonage Rd northerly, to the jct of Rte 136.
Map ID 2 is in Pownal - Elmwood Rd, From the jct of Lawrence Rd easterly, to the jct of Rte 9.
Map ID 3 is in Gray - Rte 115, From the jct of Rte 26 easterly, to the jct of Depot Rd.
Map ID 4 is in Falmouth, Cumberland - Rte 26, From 0.1 mi s\o the Falmouth TL northerly, for 1.1 miles at bottom of truck lane.
Map ID 5 is in Mechanic Falls - Rte 124, From the jct of Rte 121\11 westerly, to the Minot TL, inc paved shldr.
Map ID 6 is in Oxford - Rte 121, From the jct of Otisfield TL northerly, to the jct of Rte 26.
Map ID 7 is in Pownal - Elmwood Rd, From the jct of Allen Rd easterly, to the jct of Lawrence Rd.
Map ID 8 is in Standish - Rte 35, From the CUL 0.08 mi n\o School St northerly, for 0.1 mi.
Map ID 9 is in Standish - Rte 35, From a point 0.47 mi n\o School St northerly, to the jct of Rte 237.

Total length is 22.48 miles

They also may be purchased by telephone at (207) 624-3536 between the hours of 8:00 a.m. to 4:30 p.m. Bid Book \$10 (\$13 by mail) payment in advance, all non-refundable.


Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of **\$20,000** payable to Treasurer, State of Maine as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.

This Contract is subject to all applicable State Laws.

All work shall be governed by "State of Maine, Department of Transportation, Standard Specifications, Revision of December 2002", price \$10 [\$13 by mail], and Standard Details, Revision of December 2002, price \$20 [\$25 by mail].
