Sealed bids addressed to the Maine Department of Transportation (Department), Augusta, Maine 04333, and endorsed on the wrapper "**Bids for Demolition/Removal of one Building Unit and any additions and or out-buildings located at 43 Mill Street in the town of Brunswick**" will be received from contractors at the Reception Desk, Maine DOT Building, Capital Street, Augusta, Maine, until **11:00 o'clock A.M.** (prevailing time) on **June 9, 2010** and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must demonstrate previous successful completion of projects with similar size and scope to be considered for the award of this Contract.

Description: PIN: 011872.01D

Location: In Cumberland County, the building is located at 43 Mill Street, in Brunswick, Maine.

Outline of Work: Demolition/ Removal of a 1-story wood frame house with full foundation and any out buildings located at 43 Mill Street in Brunswick. The buildings may be inspected by contacting Andrew Johnson of Maine Dot Property Office at (207) 624-3345 to arrange entry.

They may also be purchased by telephone at (207) 624-3536 between the hours of 8:00 A.M. to 4:30 P.M. Costs are \$10.00 (\$13.00 by mail) for bid books, payment in advance, all non-refundable.


Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of \$ 500.00 payable to Treasurer, State of Maine, as a bid guarantee. If the low bid exceeds \$100,000.00, a Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful bidder. If a bid indicates a credit to the State, the Department requires a bidder to forward a separate credit amount for the credit bid in the form set forth in the Special Provisions.

This contract is subject to all applicable federal laws and to compliance with the Disadvantaged Business Enterprise requirements as set forth by the Maine Department of Transportation.

All work shall be governed by "State of Maine, Department of Transportation, Standard Specifications, Revision of December 2002", priced at \$10.00 [\$13.00 by mail], and *Standard Details, Revision of December 2002*, priced at \$20.00 [\$25.00 by mail].
