To whom it may concern,

Acadia National Park representatives met with MDOT Regional Transportation Planner, Matthew Drost to discuss several projects that benefit visitor access to Acadia National Park.

The work includes road surface treatments and lane alignment to accommodate alternative transportation users and the engineering, design, and construction of adequate drainage. In addition, the work includes repairs to a significant culvert/bridge structure in poor condition. Should this culvert experience a failure it would have deleterious effects on visitor access to Acadia. All work is within the right-of-way of the roads that directly provide access to the National Park.

We acknowledge MDOT's application for FLAP funding and fully endorse the projects that the State is considering for providing safe access to Acadia National Park.
