#### March 1, 2010

Commissioner Vestal called the March 1, 2010 Commission meeting to order at 8:33 a.m. Present were Commissioners: Paul Vestal, Sallie Chandler, Joe Perry, and A. Mavourneen Thompson.

Commissioner Vestal called for adoption of the agenda.

Commissioner Chandler moved, seconded by Commissioner Perry to adopt the agenda as amended. 4 in favor | 0 opposed.

Commissioner Chandler moved, seconded by Commissioner Perry, to accept the Investigator's recommendations in each of the cases on the revised Consent Agenda. 4 in favor | 0 opposed.

## **MINUTES**

Commissioner Perry moved, seconded by Commissioner Chandler, to adopt the January 11<sup>th</sup> Commission Meeting Minutes as amended. 4 in favor | 0 opposed.

#### INVESTIGATION

- New Charges: Commission staff opened 66 new cases in January.
- Administrative Dismissals: Commission staff administratively dismissed 11 cases in January.
- Pre-determination Settlements: During the months of January, investigators were responsible for obtaining settlements in 14 cases resulting in a total monetary relief in excess of \$140,710.

## **NEW BUSINESS:**

There was no new business to discuss.

E08-0336: Christopher Plaice (New Gloucester) v. Bill Dodge Buick-Pontiac, Inc. (Westbrook). Christopher Place restated the position of the respondent. Attorney David Hirshon restated the position of the Respondent. Field Investigator Robert Beauchesne restated the facts of the case. Commissioner Chandler moved, seconded by Commissioner Perry to find no reasonable grounds to believe that the Complainant, Christopher Plaice, was subjected to unlawful discrimination in employment (terms and conditions of employment or termination) due to his physical disability. 3 in favor | 1 opposed. (Thompson opposed).

At 9:23 a.m. Commissioner Fredette joined the meeting.

E08-0372: Wendy Eckert (Bangor) v. University of Maine System (Bangor). Attorney Jeffrey Neil Young restated the position of the Complainant. Attorney Kelly Wiltbank restated the position of the Respondent. Field Investigator Robert Beauchesne restated the facts of the case. Commissioner Thompson moved, seconded by Commissioner Perry to find reasonable grounds to believe that the Complainant Wendy Eckert, was subjected to illegal sexual harassment or retaliation by the Respondent as a result of the Complainant's whistleblowing in making a report of sexual harassment. 2 in favor | 3 opposed. (Vestal, Chandler, Fredette opposed). Motion Failed. Commissioner Fredette moved, seconded by Commissioner Chandler to find no reasonable grounds to believe that the Complainant Wendy Eckert, was subjected to illegal sexual harassment or retaliation by the Respondent as a result of the Complainant's whistleblowing in making a report of sexual harassment. 3 in favor | 2 opposed. (Perry, Thompson opposed)

E08-0475: George Loder, Jr. (Scarborough) v. State of Maine/Maine State Police (Augusta). George Loader restated the position of the Complainant. Assistant Attorney General Melissa O'Dea restated the position of the Respondent. Commissioner Fredette moved, seconded by Commissioner Perry to find no reasonable grounds to believe that the Respondent, State of Maine, Department of Public Safety, Maine State Police, failed to promote Complainant, George W. Loader, Jr., because of whistleblower retaliation. 4 in favor | 0 opposed | 1 abstained (Vestal)

E08-0511: Janet Floyd (Cornish) v. Vulcan Electric Company (Porter). Attorney Mark Dunlap restated the position of the Respondent. Attorney Maria Fox restated the position of the Complainant. Chief Investigator Barbara Lelli restated the facts of the case. Commissioner Chandler moved, seconded by Commissioner Perry to find reasonable grounds to believe that the Respondent, Vulcan Electric Company, demoted Complainant and constructively discharged her, due to her age and gender. 2 in favor | 3 opposed (Vestal, Fredette, Thompson opposed). Motion Failed. Commissioner Fredette moved,

seconded by Commissioner Vestal to find no reasonable grounds to believe that the Respondent, Vulcan Electric Company, demoted Complainant and constructively discharged her, due to her age and gender. 3 in favor | 2 opposed. (Chandler, Perry opposed)

E08-0513: Lee Veilleux (Livermore Falls) v. MSAD 52 (Turner). Attorney Elly Burnett restated the position of the Complainant. Attorney Michael Poulin restated the position of the Respondent. Chief Investigator Barbara Lelli restated the facts of the case. Commissioner Perry moved, seconded by Commissioner Thompson to find no reasonable grounds to believe that the Respondent, MSAD 52, recommended Complainant, Lee Veilleux's employment be terminated due to his age or physical disability. 5 in favor | 0 opposed. Commissioner Fredette moved, seconded by Commissioner Perry to find no reasonable grounds to believe that the Respondent, MSAD 52, denied Complainant a reasonable accommodation for his physical disability. 5 in favor | 0 opposed.

E08-0517: John Herald (Windham) v. Energy East Management Corp (NY)

E09-0099: John Herald (Windham) v. Utility Shared Services Corporation (NY): Attorney Jeffrey Neil Young restated the position of the Complainant. Attorney Katherine Rand restated the position of the Respondent. Field Investigator Michele Dion restated the facts of the case. Commissioner Fredette moved, seconded by Commission Chandler to find no reasonable grounds to believe that the Respondents, Energy East Management Company, Utility Shared Services Corporation, or Energy East Corporation, discriminated against Complainant, John Herald, on the basis of age or retaliated against him for filing a complaint of age discrimination. 5 in favor | 0 opposed.

PA08-0627: Barbara Hustus (Glenburn) v. State of Maine/DHHS (Bangor)

PA08-0627-A: Barbara Hustus (Glenburn) v. J. Cadman (Bangor): Attorney Michael Guare restated the position of the Complainant. Assistant Attorney General Susan Herman restated the position of the Respondent. Commissioner Fredette moved, seconded by Commissioner Chandler to find **reasonable grounds** to believe that Respondents, State of Maine, Department of Health and Human Services, and Janel Cadman, discriminated against Barbara Hustus because of her race, ancestry, and national origin. 5 in favor | 0 opposed.

E09-0120: Russell Bearor (Waterboro) v. City of Westbrook: Attorney Paul Boots restated the position of the Complainant. Attorney Robert Bower restated the position of the Respondent. Commissioner Chandler moved, seconded by Commissioner Fredette to find no reasonable grounds to believe that the Respondent, City of Westbrook, terminated Complainant, Russell L. Bearor's employment because of sex or that the Respondent denied the Complainant a reasonable accommodation for his disability. 5 in favor | 0 opposed.

E09-0227: Kimberly Olsen (Lewiston) v. Alternative Services Northeast, Inc. (Lewiston). Complainant was not present. Respondent was not present. Commissioner Fredette moved, seconded by Commissioner Chandler to find no reasonable grounds to believe that the Respondent, Alternative Services Northeast, Inc., retaliated against Complainant, Kimberly J. Olsen, because of her whistleblower activity. 5 in favor | 0 opposed.

E09-0232: Keith Whitmore (Gray v. TrueBlue, Inc. / Labor Ready Northeast, Inc. (WA)

E09-0233: Keith Whitmore (Gray) v. Inn Yarmouth LLC d/b/a Hampton Inn (Freeport): Complainant was not present. Commissioner Fredette moved, seconded by Commissioner Chandler to find no reasonable grounds to believe the respondents, Inn Yarmouth, LLC d/b/a Hampton Inn or TrueBlue, Inc./Labor Ready Northeast, Inc. terminated Complainant, Keith F. Whitmore's employment because of disability, retaliation or whistleblower retaliation. 5 in favor | 0 opposed.

H09-0510: Daniel Mitchell (Bangor) v. Jay A. Smith, Inc./P. Gott (Brewer). Attorney Patricia Ender restated the position of the Complainant. Jay Smith restated the position of the Respondent. Field Investigator Angela Tizon restated the facts of the case. Commissioner Fredette moved, seconded by Commissioner Chandler to find no reasonable grounds to believe that Jay. A. Smth, Inc or Patricia Gott discriminated against Daniel Mitchell on the basis of his national origin or ancestry. 5 in favor | 0 opposed.

H08-0660(A-C): Henry Jackman & Amy Jackman (Berwick) v. Chuck Dog Realty Trst et al (MA): Attorney Patricia Ender restated the position of the Complainant. Respondent was not present. Commissioner Fredette moved, seconded by Commissioner Chandler to find no reasonable grounds to believe that Respondents Brian O'Neil or Chriss Anne Cormier subjected the Complainants, Henry and Amy Jackman, to unlawful housing discrimination based on disability or retaliated against them for filing a complaint of housing discrimination. 5 in favor | 0 opposed. Commissioner Fredette moved, seconded by Commissioner Chandler no reasonable grounds to believe that Respondents Abraham Schlosberg, Trustee, Chuck Dog Realty Trust, subjected the Complainants, Henry and Amy Jackman, to unlawful disability discrimination in the terms and conditions of rental based on disability, or denied them a reasonable accommodation. 5 in favor | 0 opposed. Commissioner Fredette moved, seconded by Commissioner Chandler **reasonable grounds** to believe that Respondents Abraham Schlosberg, Trustee, Chuck Dog Realty Trust, subjected the Complainants, Henry and Amy Jackman, to retaliation for filing a complaint of housing discrimination. 5 in favor | 0 opposed.

Commissioner Chandler moved, seconded by Commissioner Fredette, to move out of executive session at 12:38 p.m. 5 in favor | 0 opposed.

Commissioner Fredette moved, seconded by Commissioner Chandler that the Commission **should not file** a complaint in E08-0469: Darcy Pinette v. Northeast Publishing Company (termination because of physical disability) 5 in favor | 0 opposed.

Commissioner Fredette moved, seconded by Commissioner Chandler that the Commission **should not file** a complaint in E08-0535, E08-0536: Brian Currie v. Anthem Blue Cross and Blue Shield & Wellpoint, Inc. 5 in favor | 0 opposed.

Commissioner Fredette moved, seconded by Commissioner Chandler that the Commission should file a complaint in H09-0134-A, B, Sheila Jacobson v. Bangor Housing Authority and Elsie Coffey. 5 in favor | 0 opposed.

In E08-0218, Susan Patti v. Coffee Couple, LLC, d/b/a Tim Hortons of Old Town; E08-0476, Brittany Corliss v. Coffee Couple, LLC, d/b/a Tim Hortons of Old Town, Calvin Boyle, and Karen Boyle; E08-0646, Anthony Verville v. Coffee Couple, LLC, d/b/a Tim Hortons of Houlton, and Calvin Boyle; E09-
