SUBJ: Revenues - March

March General Fund revenues were under budget by \$31.2 million or 13.5%. For the first nine months of FY13, General Fund revenues are \$5.1 million under budget (-0.3%). Compared to the same nine month period last fiscal year, revenues are flat.

Sales & use tax receipts were significantly under budget for the month of March (February sales) by \$11.1 million. Part of the monthly variance was the result of weak February sales, but some is from a monthly distribution that failed to take into account the adjustment in last March's Controller's Report for an accounting error earlier in FY12. The error in the monthly distribution has no impact on the year-to-date variance only in evaluating January and March's performance. A corrected distribution shows that January revenues were under budget by \$10.3 million rather than \$3.7 million and March revenues were under budget by \$4.5 million compared to the \$11.1 million on the current Controller's report. Either way the end result is the same, the last three months of sales tax receipts have been on a roller coaster ride with January and March revenues significantly under budget and February on budget.

Individual income tax was under budget for the month by \$10.8 million. Most of the negative variance was from withholding receipts. At the moment it appears that timing is the reason for withholding being under budget by so much and it's expected to correct itself over the remaining months of the fiscal year. Year-to-date individual income tax is over budget by \$38 million.

Corporate income tax receipts were under budget for the month by \$6.6 million and are \$13.2 million under budget for the fiscal year. 2012 tax returns were due on March 15th for calendar year filers. March final payments were under budget by \$2.6 million. Estimated payments accounted for the remainder of the negative variance. Calendar year filers are required to make their first estimated payment of 2013 in April.

Sales & Use Taxes

Revenue was \$11.1 million under budget for the month and \$16.6 million (-2.5%) under budget fiscal year-to-date. Fiscal year-to-date revenue was \$2.8 million (-0.4%) under fiscal year 2012.

Taxable Sales

Total taxable sales for the month of February (March revenue) were down 4.7% from February 2012. The annual rate of change was up 2.1%. Building supply sales were down 8.7% for the month and 3.8% for the year ending in February. Sales of taxable items in food stores were down 2.4% for the month and up 2.6% for the year. General merchandise sales (primarily sales of goods sold in large department and discount stores) were down 8.5% for the month and up 1.2% for the year. Sales in other retail stores such as jewelry, drug, sporting goods, book, antique, pet, photo, toy, and craft stores were down 3.8% for the month and up 0.3% for the year. Auto/transportation sector sales were down 4.6% for the month and up 4.1% for the year. Sales of meals and other prepared foods were down 7.4% for the month and up 4.3% for the year. Lodging sales were up 4.2% for the month and 7.5% for the year. Business operating sales (primarily use tax paid by businesses) were up 3.4% for the month and 3.4% for the year.

Service Provider Tax

Revenue was \$361,595 under budget for the month and \$1.9 million (-5.4%) under budget fiscal year-to-date.

Individual Income Tax

Revenue was \$10.8 million under budget for the month and \$38 million (+4.1%) over budget fiscal year-to-date. Fiscal year-to-date withholding payments were 0.1% over fiscal year 2012. Estimated payments were up 22.9% and final payments were up 2.8% fiscal year-to-date. Fiscal year-to-date revenue was \$35 million (+3.8%) over fiscal year 2012.

Corporate Income Tax

Revenue was \$6.6 million under budget for the month and \$13.2 million (-11.2%) under budget fiscal year-to-date. Estimated payments were down 14.8% and final payments were down 35.8% fiscal year-to-date. Fiscal year-to-date revenue was \$53.4 million (-33.9%) under fiscal year 2012.

Cigarette & Tobacco Taxes

Cigarette and tobacco products tax revenue was \$1.1 million over budget for the month and \$42,441 (0.0%) under budget fiscal year-to-date.

Insurance Companies Taxes

The Insurance Companies Taxes were \$1.8 million under budget for the month and \$1.5 million under budget fiscal year-to-date.

Estate Tax

The estate tax was \$999,556 under budget for the month and \$3.6 million under budget fiscal year-to-date.

Transfers for Tax Relief Programs

Refunds for the tax & rent, Business Equipment Tax Reimbursement (BETR) and Business Equipment Tax Exemption (BETE) were under budget in March by \$0.2 million, and are now \$0.8 million under budget for the fiscal year.

Municipal Revenue Sharing

Revenue sharing was under budget for the month by \$0.750 million. Year-to-date revenue sharing is over budget by approximately \$2.2 million.

Lottery

Lottery Revenues were over budget for the month by \$1.9 million or 37.2%. For the first nine months of the fiscal year lottery receipts are \$0.2 million under budget.

Other Revenues

Other Revenues were under budget by \$0.4 million for the month, a variance of 11.2%. For the fiscal year other revenues are \$0.6 million over budget.

Highway Fund

Motor fuel tax receipts were under budget in March by \$0.5 million. The Highway Fund as a whole was also under budget for the month by \$0.7 million. Fiscal year-to-date motor fuel excise taxes are \$2.6 million under budget (-1.8%) and the total Highway Fund is under budget by \$1.9 million (-0.9%).

National Economy

Similar to previous years the US economy appears to be slowing after a period of positive economic reports. March economic data such as the disappointing jobs and retail sales reports indicate that rising federal taxes, sequestration and higher energy prices have taken their toll on the economy. While economic growth continues, the average growth of 2% experienced over the last few years appears to be holding firm. The fiscal impact of tax and spending changes in Washington is expected to keep the pace of economic and job growth consistent with previous

years over the remainder of the calendar year. In addition, the global economy and events like the bombing in Boston have the potential to slow the economy further.

Maine Economy

With the exception of a burst of spending in January, Maine consumers are struggling with the rise in federal payroll taxes and high energy prices. Similar to other Northeastern states, Maine taxable sales were weak in December, strong in January and weak again in February. While comparisons with the same months last year are difficult because of the warm winter in 2012, adjusting for that factor still results in a firm conclusion that low and middle income households are finding it difficult to adjust to the higher payroll tax at the federal level. With energy prices falling in recent weeks and a more normal spring weather pattern this year, we expect to see consumer spending firm up during the second quarter of 2013 and begin to return to a more moderate rate of growth during the summer tourism season. A reversal of energy prices, misstep in fiscal policy or international event could quickly change that forecast.
