If the professional does not provide such reports in a timely manner, the Board shall notify Dr. LaBelle and if this deficiency is not cured in ten (10) days then the Board can declare a breach of this Consent Agreement.

**All other portions of the November 24, 2009 Consent Agreement and Board Order remain in effect.**






