## ***General Qualifications for County Office (21-A MRS §333):***

As of the deadline for filing nomination petitions for the general election ballot, the person must:

- Be a resident of the county for which the person seeks the office of Sheriff; and
- Be a registered voter in the county for which the person seeks the office of Sheriff.

The person must maintain a voting residence in this county during the entire term of office.

## ***Additional Qualifications for County Sheriff (30-A §371-B):***

Each candidate for the office of County Sheriff must complete either **(A.) Statement of Qualifications** or **(B.) Statement of Exception** by placing a check mark by the appropriate statement. The candidate also must complete the candidate's consent on the reverse side of the form and have the consent notarized before a Notary Public.

**A. Statement of Qualifications** *(Pursuant to 30-A MRS §371-B, Sub-§3)*

- I agree to submit to a criminal background investigation to confirm that I have not been convicted of a Class C or higher crime.

- I have attached written certification from the Maine Criminal Justice Academy that:
  - 1) **I am currently certified** as a law enforcement officer and have met the basic law enforcement training standards under Title 25, section 2804-C; or
  - 2) **I was previously certified** as a law enforcement officer and agree to meet the basic law enforcement training standards under Title 25, section 2804-C within one year of taking office.
- I further swear or affirm that I have at least two years of supervisory employment experience in law enforcement or corrections or a combination of both and have submitted the name, address and telephone number for the relevant employer or employers. *(Attach a separate sheet providing the name, address and phone number of the employer, or employers, under which you have met this qualification.)*

**B. Statement of Exception** *(Pursuant to 30-A MRS §371-B, Sub-§4)*

- I hereby attest that I meet the qualifications contained in 30-A MRSA § 371-B, Sub-§ 3, because I served as a full-time law enforcement officer employed by a municipal police department or a state agency, including the University of Maine system, on or before July 1, 1990 or was serving in the office of sheriff on June 26, 2021, or had served in the office of sheriff prior to that date.
