What should I do now?

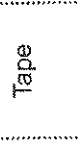
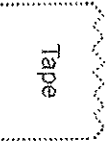
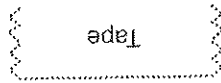
Complete and sign the enclosed voter registration form, tape it shut, and mail it. No stamp required! If any of your info is printed incorrectly, cross it out and correct it.

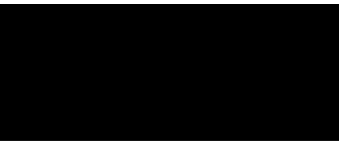

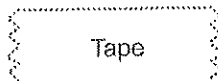

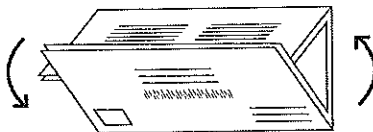
